First clean and degrease the surface which will be coated with MOLYKOTE 3402 C Anti-Friction

Coating. Phosphatization or sandblasting (180 grid) increases the adhesion and service life.

How to apply

Stir the Anti-friction Coating thoroughly before applying by spraying, dipping, centrifuging or brushing. Recommended dry film thickness: 5 to 20µm.

Curing

120 minutes at 20°C (68°F).

Solubility

Thinning can be carried out using MOLYKOTE® L 13 Thinner.
